We would like to purchase Reading A-Z and Raz-kids licenses for all the first grade classrooms.

Reading A-Z offers an online guided reading program with high quality reading materials for grades 1-6. The scope and sequence of reading resources is vast for the small cost. It supplies fluency drills, leveled books, and poetry to help differentiate learning. Reading A-Z has been used throughout grade levels at Apollo. In previous years the first grade team has been able to optimize student learning while providing appropriate take home materials to all students at their individual need. Reading A-Z allows license holders to print and copy numerous amounts of "just-right" books to send home with students. Not only does Reading A-Z offer in class reading support during a balanced literacy block (daily 5 rotation), but it allows for additional support at home.

Raz-kids is from the same company as A-Z readers, but offers different components. Razkids allows students to listen to books read aloud, read with vocabulary and pronunciation support, and read without support (as the program is his/her support). Students can also practice reading to improve reading comprehension anywhere with Internet access (at home, at the library, etc.). It allows teachers

to easily limit students to appropriate reading levels and specific books and track students' reading progress. This aspect is wonderful since students are doing this option during daily 5 when the teacher is working with a small group.

Combining Reading A-Z and Raz-Kids will allows us to maximize the resources and benefits of each site in addition to an enhanced version of the Book Room (printable books mentioned earlier). Subscribing to both will allow us to get an additional 750+ eBooks and open-book eQuizzes helping us seamlessly connect our instructional tools on Reading A-Z to the student activity on Raz-Kids. Then, when an assessment from Raz-Kids shows that a student needs more help with a particular skill, we can easily find individualized, "just-right" Reading A-Z resources for the student.

2. How will this integrate into the school's curriculum?

Reading A-Z offers an online guided reading program that supports Issaquah School District's balanced literacy program. It is a great component for daily 5 rotations during a literacy block. Reading A-Z is constantly expanding and keeping up to date with state reading standards and the Common Core State Standards.

Raz-Kids is an excellent addition to the A-Z readers Apollo started using last year which allows students to work at their own individual level. This program gives the students additional resources at their level and provides the teacher instant feedback on how well that student comprehends what they are reading. This is all possible while the teacher is working in small groups with other students. Raz-Kids provides teachers with resources to support a balanced literacy approach which the Issaquah School District adopted in prior years. Along with Making Meaning (which focuses on comprehension) and Fountas and Pinnell Phonics, Raz-Kids provide students with the necessary practice to become fluent and sophisticated readers.
